Definitions

Room Only:	Accommodation only No Food Provided
B&B Continental:	Room with juice, cereal, fresh fruit, toast/bread, tea/coffee
B&B Full Irish:	Room with juice, cereal, bacon, sausages, egg, toast/bread, tea/coffee
*Clean Towels/Bed Linen Provided	Hand Towel, Bath Towel, 1 Duvet, 2 Pillows per person, Mattress Protector, Pillow Cases, 2 Sheets, 1 Towel per person
*Sanitary Facilities	Access to toilet, Hand Basin, Shower/Bath - en-suite or near a bathroom
*Door Keys Provided	Key for House and Key for Bedroom
*Central Heating	Oil or Gas heating provided in bedroom
*Guest Wardrobe/Cupboard IN EACH BEDROOM	Area for hanging and storing clothes and shoes
*Shower Facilities	Shower with Hot and Cold water in working condition
*Smoke Alarm	A device that senses smoke
*Blinds/Curtains for Bedrooms	Provide privacy to individual staying in bedroom
Access to Kitchen Kettle, Toaster, Fridge	Guest is allowed to use kettle, toaster, fridge in kitchen
Laundry Facilities Washing Machine, Iron, Ironing Board	Area to wash, dry and iron clothes
Internet Access	Free access to Internet
Off Street Parking	Free parking place for car that is not on main road
Disabled Access	Accommodation suitable for a person with special needs or disability
Pets Welcome	Accommodation pets are also welcome to stay

Important Information

Revenue Implications:	The onus is on each home owner to declare any additional income to revenue.												
Insurance Implications:	The onus is on the home owner to advise their insurance company on their plans.												
Loss of Keys:	The onus is on the home owner to replace lost keys. They may charge a fee for replacement.												
Collecting and returning keys:	This is to be arranged directly between the home owner and visitor.												
Heating System:	The onus is on the house owner to provide information on how the heating system works, how it can be turned on and how often it automatically comes on (if relevant).												
Pull Out/Inflatable Beds:	Charge agreed house rate.												
Will there be more accommodation visits?	Ad hoc revisits will take place closer to the Fleadh.												
Are council tenants allowed to register accommodation?	No, council tenants are not allowed register rooms or houses/apartments.												
Alarm Systems:	Full instruction on how to operate Alarm System should be provided where applicable.												
Contact Person during stay:	Name & contact number of property owner should be provided to visitor in case of emergency.
